

Bill Status Report: 1.31.25

During the third week of the 2024 legislative session, the [PPSO Team](#) continued to monitor, analyze, and report on legislation affecting the University of Washington and higher education in Washington state more broadly. The table below is a comprehensive overview of all bills the [PPSO Team](#) is currently tracking this session. To provide deeper insight into the impact of this legislation, we have highlighted three noteworthy pieces of legislation that could impact the overall well-being of both current and future students.

[SB 5275](#)– Modifying funding and award levels for the passport to careers program and eligibility for the Washington college grant.

This bill expands financial aid access for former foster youth and homeless students by automatically qualifying them for the Washington College Grant without requiring a FAFSA or WASFA. It also moves the Passport to Careers program to an entitlement model, ensuring all eligible students receive up to \$5,000 annually in financial support, adjusted for tuition increases. The bill aims to provide more predictable and stable funding for this vulnerable student population.

[SB 5402](#) (HB 1568)- Modifying financial aid eligibility.

This bill increases financial aid access by raising income limits for the Washington College Grant, allowing families earning up to 70% of the state median family income (MFI) to receive full awards and those earning up to 100% MFI to receive prorated awards. It also permanently establishes the \$500 Bridge Grant to help low-income students cover additional costs like books and transportation.

[SB 5308](#) (HB 1557)- Establishing the Washington guaranteed admissions program and requiring student notifications.

This bill creates the Washington Guaranteed Admissions Program (WAGAP) to simplify college admissions for high school students. It would allow eligible students to receive automatic admission offers from participating public universities based on GPA and coursework. The bill also requires schools to share student data with colleges and provide notifications about financial aid and postsecondary opportunities, making the admissions process more transparent and accessible.

Our list of tracked legislation has grown from **165 bills** in the first weeks of the session to **240 bills** as we end the second week.
