

Bill Status Report: 2.14.25

During the fifth week of the 2024 legislative session, the [PPSO Team](#) continued to monitor, analyze, and report on legislation affecting the University of Washington and higher education in Washington state more broadly. The table below is a comprehensive overview of all bills the [PPSO Team](#) is currently tracking this session. To provide deeper insight into the impact of this legislation, we have highlighted three noteworthy pieces of legislation that could impact the overall well-being of both current and future students.

[SHB 1136](#) - Providing student navigational supports to increase postsecondary enrollment.

This bill would establish a new program to increase FAFSA and WASFA completion rates and support postsecondary enrollment, replacing an existing pilot program. It would fund outreach specialists in districts with low financial aid application rates to help students and families navigate college and financial aid processes. The bill also requires financial aid training for educators and an annual report on program effectiveness.

[HB 1190](#) - Allowing additional health professions to access the University of Washington health sciences library.

This bill would allow additional health professionals to access the University of Washington Health Sciences Library by adding a fee to their licensing costs. The expanded access would include various licensed health care providers, such as psychologists, dietitians, speech-language pathologists, and acupuncturists. Fees collected by the Department of Health would be transferred to the University of Washington to support this initiative.

[HB 1337](#) - Concerning the appointment of presidents of institutions of higher education.

This bill would require public universities to publicly announce up to four finalists for the position of president at least 30 days before making a final hiring decision. Candidate application materials would be made public, and each finalist would participate in a public forum to engage with students, faculty, and staff. The final hiring decision would take place in an open public meeting, ensuring greater transparency and public input in the selection process.

Our list of tracked legislation has grown from **388 bills** in the third week of session to **409 bills** as we end the fourth week.
