

Bill Status Report: 2.7.25

During the fourth week of the 2024 legislative session, the [PPSO Team](#) continued to monitor, analyze, and report on legislation affecting the University of Washington and higher education in Washington state more broadly. The table below is a comprehensive overview of all bills the [PPSO Team](#) is currently tracking this session. To provide deeper insight into the impact of this legislation, we have highlighted three noteworthy pieces of legislation that could impact the overall well-being of both current and future students.

[SB 5540](#) (HB 1843) - Concerning students' eligibility to receive unemployment insurance benefits.

This bill removes the current restriction that prevents students from qualifying for unemployment benefits based on their enrollment status. If passed, student workers who lose their jobs would be eligible to apply for unemployment benefits like other workers.

[SB 5541](#) (HB 1661)- Concerning the Washington future fund pilot project.

This bill would create a pilot program to evaluate the impact of a one-time \$25,000 grant for eligible low-income young adults to use toward education, homeownership, or business development. The program would be designed and assessed in collaboration with the University of Washington and a third-party vendor, with findings reported to the legislature. The pilot aims to explore financial strategies for improving long-term economic stability.

[HB 1298](#) (SB 5158) - Concerning student athlete insurance.

This bill would allow public four-year institutions to provide and cover the cost of insurance for intercollegiate student athletes. The coverage could include both current student athletes and former athletes who qualify for post-eligibility health care under athletic association rules. Institutions would have the option to offer this insurance but would not be required to do so.

Our list of tracked legislation has grown from **240 bills** in the third week of session to **388 bills** as we end the fourth week.
