

Bill Status Report: 3.7.25

During the eighth week of the 2025 legislative session, the [PPSO Team](#) continued to monitor, analyze, and report on legislation affecting the University of Washington and higher education in Washington state more broadly.

This past week, numerous bills were heard in their respective houses of origin as we quickly approach the **House of Origin Cut-off** deadline on **Wednesday, March 12th**. This deadline signifies the last day to consider bills in their respective houses of origin. Any bills that do not pass out of the chamber they originated in are considered “dead” and will not continue through the legislative process unless deemed NTIB (Necessary to Implement the Budget). Any proposed legislation that passed off the floor in their house of origin will move to the appropriate policy committee in the opposite chamber for consideration. For additional context, we have highlighted three pieces of legislation that we were tracking that are now considered “dead” and will no longer be considered during this legislative session. [SHB 1557](#) (Dead) - Establishing the Washington guaranteed admissions program and requiring student notifications.

This bill would have created the Washington Guaranteed Admissions Program to expand access to public four-year institutions by granting automatic admission to eligible high school students. It required participating institutions to simplify the admissions process and school districts to share student data to facilitate guaranteed admissions. The bill also mandated student and family notifications about college opportunities and allowed institutions to opt out with a report on alternative access initiatives

[SHB 1136](#) (Dead) - Providing student navigational supports to increase postsecondary enrollment.

This bill would have established a new program to improve FAFSA and WASFA completion rates and support postsecondary enrollment, replacing an existing pilot program. It would have funded outreach specialists in districts with low financial aid application rates to assist students and families in navigating college and financial aid processes. Additionally, the bill would have required financial aid training for educators and an annual report to assess program effectiveness.

[SSB 5321](#) (Dead) - Concerning access at public postsecondary educational institutions to medication abortion.

This bill would have required Washington's public postsecondary institutions to expand access to medication abortion by the 2026-27 academic year. Campuses with student health centers would have been required to offer these services directly or through telehealth, while campuses without health centers would have needed to provide referrals, private telehealth spaces, and technical support. The bill also would have required all institutions to update their health services websites with reproductive health resources and information on academic accommodations related to pregnancy.

As we conclude the eighth week, our list of tracked legislation has grown from **433** bills last week to **435** bills.
