

Bill Status Report: 4.18.25

During the fourteenth week of the 2025 legislative session, the [PPSO Team](#) continued to monitor, analyze, and report on legislation affecting the University of Washington and higher education in Washington state more broadly.

On **April 8th**, the Legislature reached the **Opposite House Fiscal Committee Cutoff**, the final day for fiscal committees in the opposite chamber to advance bills. This was followed by the **Opposite House Cutoff on April 16th**, marking the last day for bills to be considered in their opposite house (with exceptions for NTIB bills and other end-of-session business). Bills that did not pass out of their opposite chamber by this deadline are considered “dead” unless designated NTIB (Necessary to Implement the Budget).

With just over a week remaining, the Legislature is approaching the **Last Day of the Regular Session on April 27**, as outlined in the state constitution.

For additional insight, we have highlighted two pieces of legislation we were tracking this session that have now passed the Legislature and are awaiting the Governor’s signature or have already been signed into law. These bills present meaningful implications for the overall well-being of current and future students, as well as the broader UW community. [E2SSB 5355](#) - Improving safety at institutions of higher education while supporting student survivors of sexual assault.

This bill strengthens protections for student survivors of sexual assault by prohibiting postsecondary institutions from pressuring students into nondisclosure agreements related to sexual misconduct reports. It also requires public four-year institutions to include contact information for sexual assault survivor support services on student ID cards. Additionally, the bill expands survivor rights by ensuring access to advocacy services, free forensic exams, and improved notification procedures related to investigations and legal proceedings

[SSB 5587](#) - Concerning affordable housing development in counties not closing the gap between estimated existing housing units within the county and existing housing needs.

This bill aims to address affordable housing shortages in counties that are not meeting their housing needs by requiring counties to assess and respond to regular reports from UW’s Washington Center for Real Estate Research. These reports will analyze housing supply and affordability metrics, track progress in closing the gap between existing housing units and housing needs, and evaluate emergency and supportive housing efforts. The legislation also prioritizes financial assistance for public works projects that promote affordable housing development in counties identified as having a housing gap.
