

Gift-Coding for Allowable Food and Alcohol Expenditures

Overview:

Expenses from gift and discretionary accounts must benefit the UW, supporting one or more of the University's missions of research, education, public service, and outreach, and the use must conform with the donor's intent for the gift. Additionally, such expenditures should be consistent with all federal and state legislation, IRS regulations, and meet the test of public scrutiny for appropriateness.

Guidance:

This guidance is intended to help units understand the food and alcohol expenditures that may be allowable on a gift and the related corresponding worktags.

- Alcohol is ONLY allowable with a discretionary resource tag in Workday (RS100203).
- Food expenditures can be made from the following Advancement fund types, in alignment with the gift agreement/documentation: support funds, faculty-appointment funds or research funds where the unit:
 - has identified the purpose as being allowable for food purchases (may be indicated by a food flag in Tandem)
 - has a documented process for how all fund types that may allow food will be consistently applied. This may include a memo or process document created by the unit with approval from the administrator or unit leadership
